Participation: concept and key components

- Participation = social, communicative and political process.
- The central components for the successful integration of participation processes into political-administrative processes are...
 - a clear objective and a structured format for participation
 - a sound understanding of the target group(s) and the selective choice of citizens in the participation process ("sampling")
 - a predefined procedure for further processing the results
 - a clearly defined approach to formats, functions and work steps ("process design")
 - continuous reflection on one's own approach ("learning loop")

The policy cycle as a structuring element



Abbildung 4: Partizipation im Policy Cycle, BMKÖS 2019

- Agenda setting/topic identification: Identification of politically & socially relevant topics
- Analysis & policy discussion: Collection & discourse of specific topics
- Policy formulation: Formulation of solutions & measures
- Decision: Selection of solutions & measures
- Implementation: Implementation of the decision & testing in practice
- **Evaluation:** Continuous monitoring of the success and impact of the implemented decisions

 \rightarrow Participation processes can improve all elements of the policy cycle, however, they also require differentiated procedures.

Civic Participation: the Austrian approach

- Goal: Create a framework for standardized, goaloriented participation processes with a practical guide
- **Framework:** Provide methods, tools and quality criteria for the different phases of the policy cycle
- Implementation: Scientific support and exchange, multidisciplinary workshops and conferences, ...

- Provided contents for the public sector:
 - General quality criteria
 - Standardized terminology
 - Caution points and stumbling blocks
 - Decision trees
 - Toolboxes
 - Checklists and questionnaires
 - Instruments for stakeholder, target group and risk analysis
 - Selected participation methods (...)




Abbildung 9: Entscheidungsbaum zur Wahl der passenden Beteiligungsintensität

5 central challenges & opportunities in the digital age

<u>Challenges</u>	<u>Opportunities</u>
Inclusion of groups without affinity for participatory processes & data protection	Automated evaluation and analysis
Changing results through digital processes, the digital process itself creates patterns of participation	Paradigm shift for the areas of inclusion and mobility
Social-communicative framework of respectful interaction	Reduced costs of participation
Difficulty understanding interactions and reactions - relevance of contextual factors	Broad scope of participants and the knowledge gained
Quality vs Quantity of the supplied information	Opportunities for extensive, systematic involvement of citizens in the political-administrative system

Civic participation in the digital age – Austrian example

Next activities in Austria and outlook on future participation

- Increased cooperation between different federal and regional authorities (f.e. parliament, regional governments and communities) and coherent knowledge transfer
- Building a "culture of participation" through intensified training courses for civil servants and communities of practices including all state levels
- Working towards a system-integrated online-participation-tool in order to reduce costs for civil servants to conduct participation processes, pending political decisions
