Building capacity in regional and local administrations

The administrations at regional and local level have a specific role in the attainment of EU policies. Public administrations at national, regional and local level are the ones that deliver crisis response, provide services, implement reforms, manage investments and, more generally, manage public spending to create expected social value. They are involved in the implementation of an important part of the EU budget as they implement 70% of all EU legislation, 70% of climate mitigation measures, 90% of climate adaptation policies and 65% of the SDGs. At the same time, most administrative reforms address mainly the needs of the central administration.

The workshop will discuss targeted approaches to improve capacity and capabilities at regional and local level to establish high quality and modern management.

Italy's economy is hindered by a kind of "twin weakness", namely a long-standing decline in public investment coupled with a persistent downfall in public employment over the last decade, particularly at the local level where the budget cuts hit more harshly, which significantly hampered the quality of the public spending. The DG REFORM project assisted Italy to enhance the implementation of National and Regional Operational Programmes, strengthening administrative capacities at national, regional and local levels to programme, coordinate and implement regional and cohesion policy along with other policy initiatives. Italy is now called upon to deliver and implement several structural reforms embodied in the Recovery and Resilience Plan.
