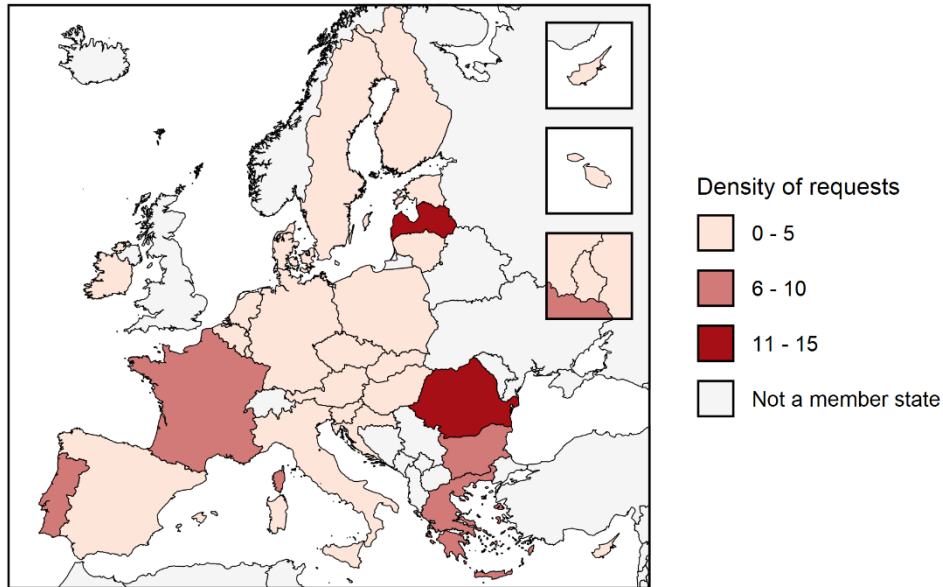
1. Overview

Number of presented and pre-selected requests

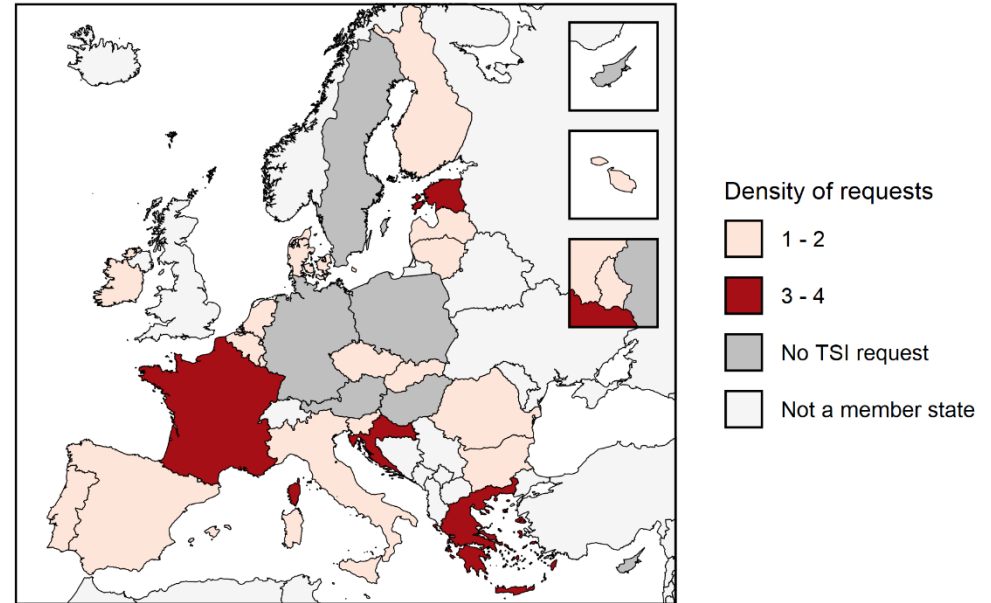
128 submitted requests

Number of selected TSI requests per country (34 requests)

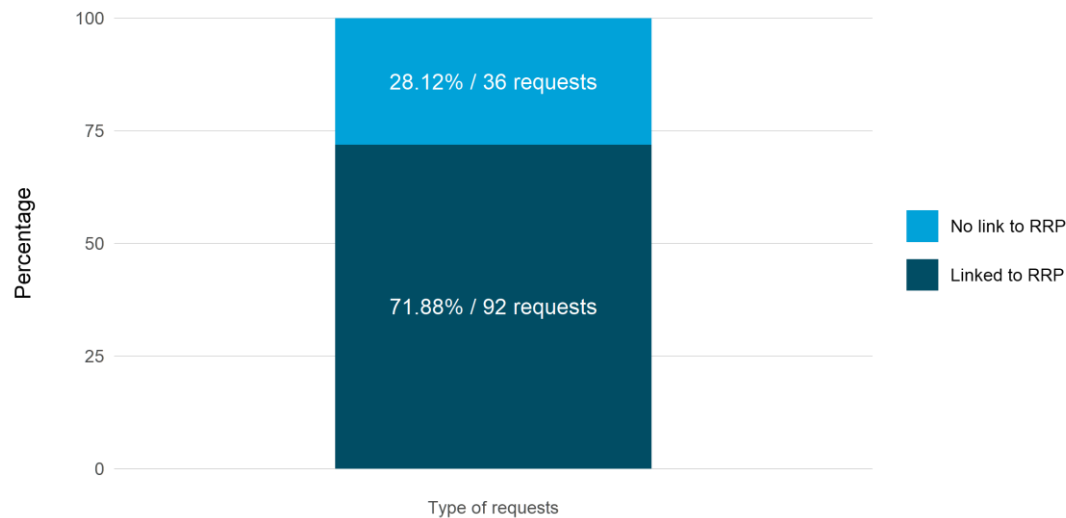


Links to the National Recovery and Resilience Plans (RRP)

All submitted requests by link with National RRP

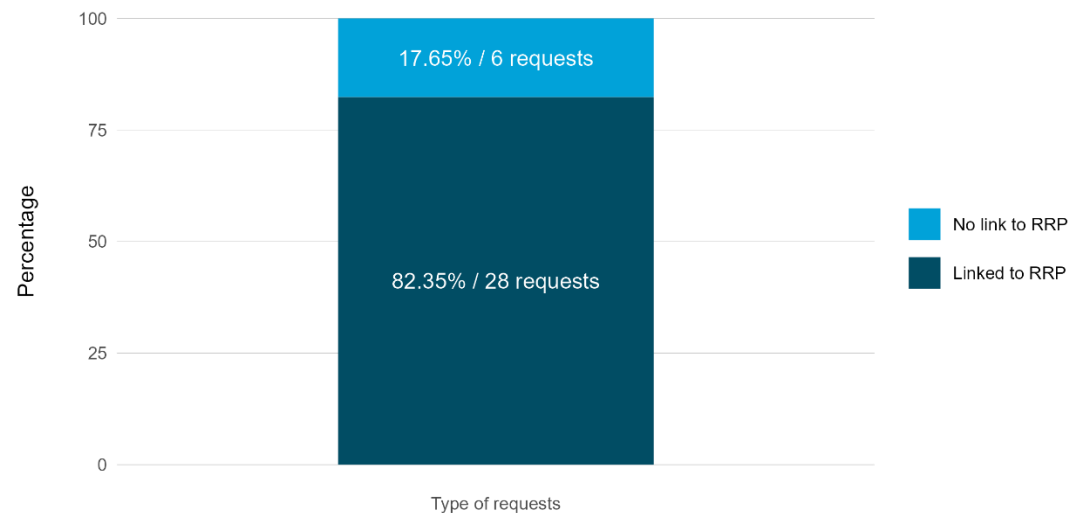
Total of 128 requests. Not including PACE requests.

Total of 34 requests. Not including PACE requests.

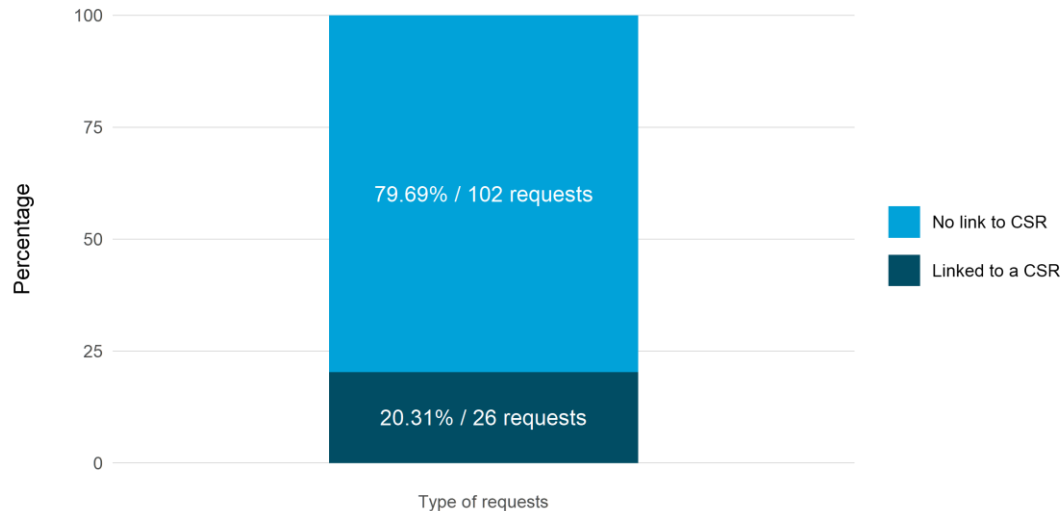


Links to the European Semester Country Specific Recommendations (CSR)

All submitted requests by link with CSRs

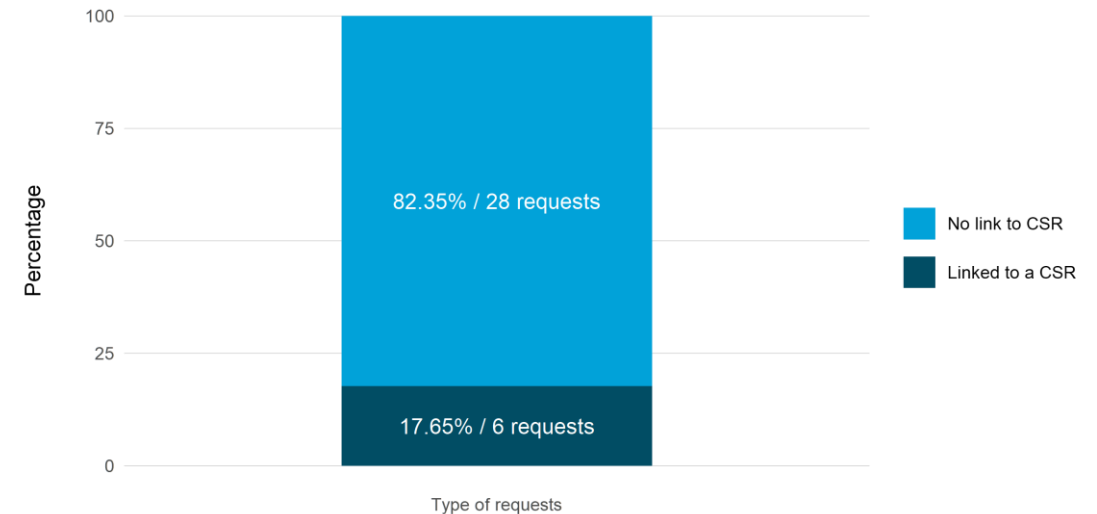

17% of pre-selected requests linked with CSRs

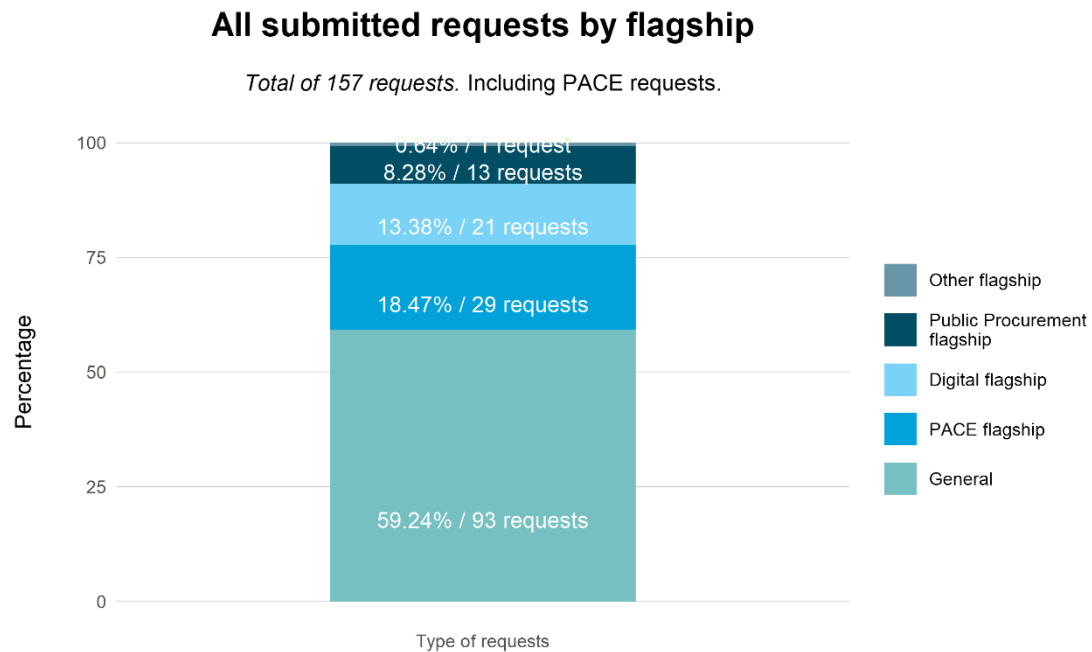

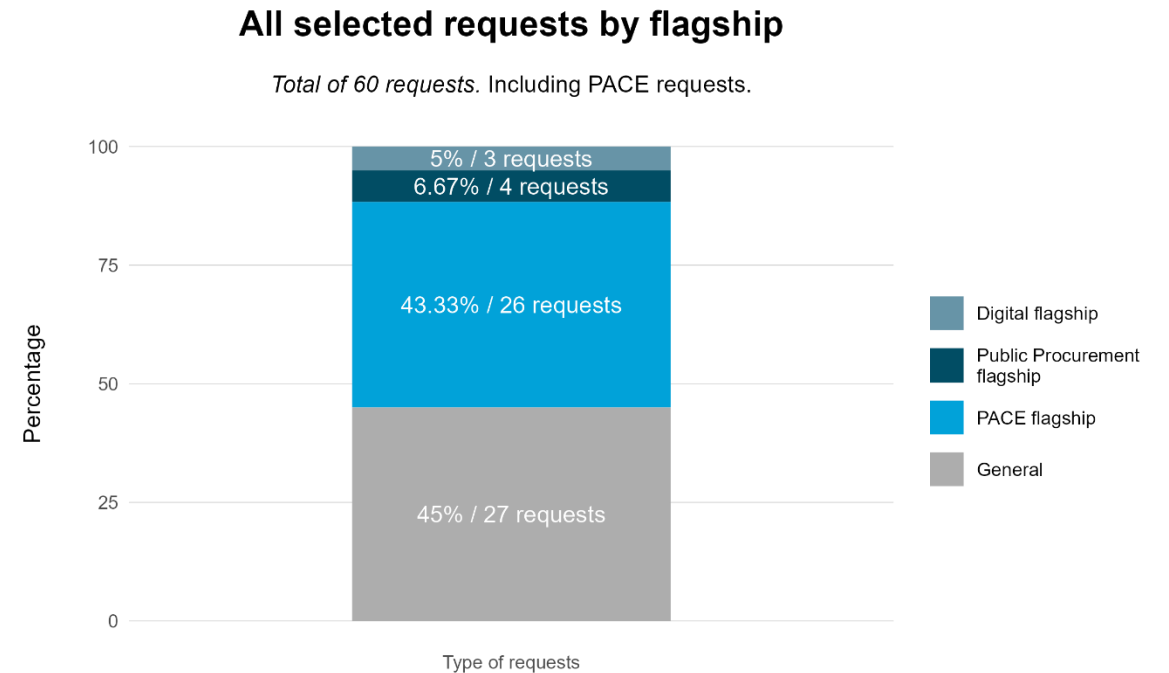


Type of requested support

Within pre-selected requests, emphasis is on PACE and general requests





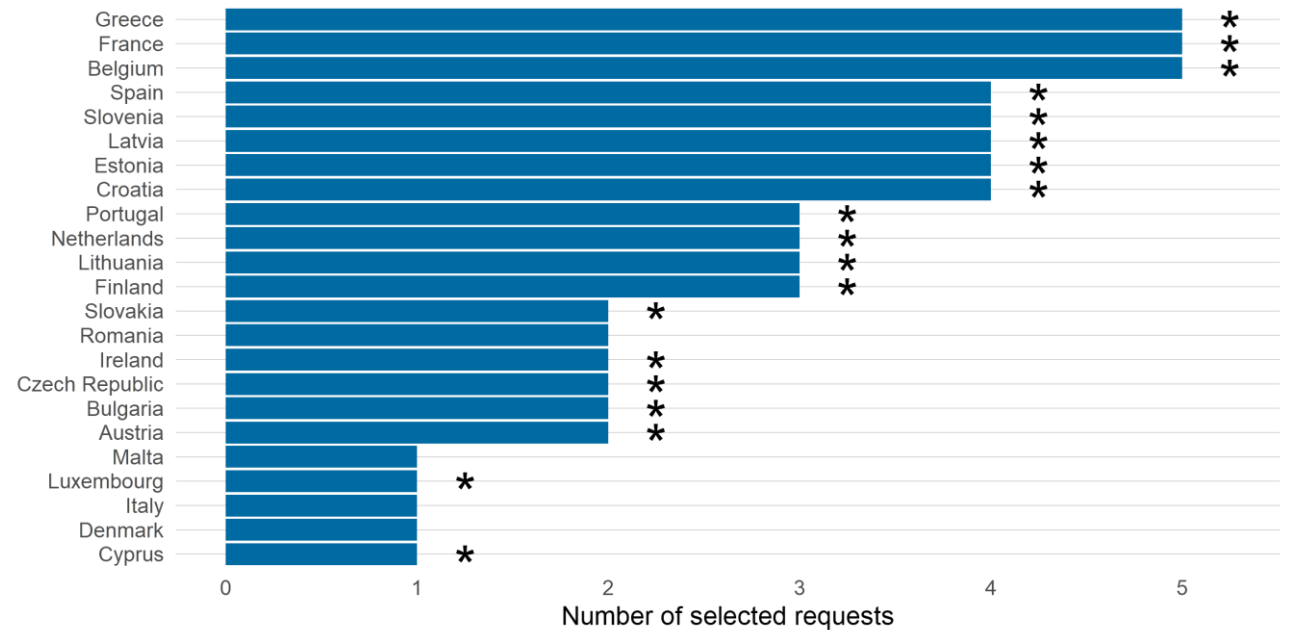
2. Requests / policy areas / countries

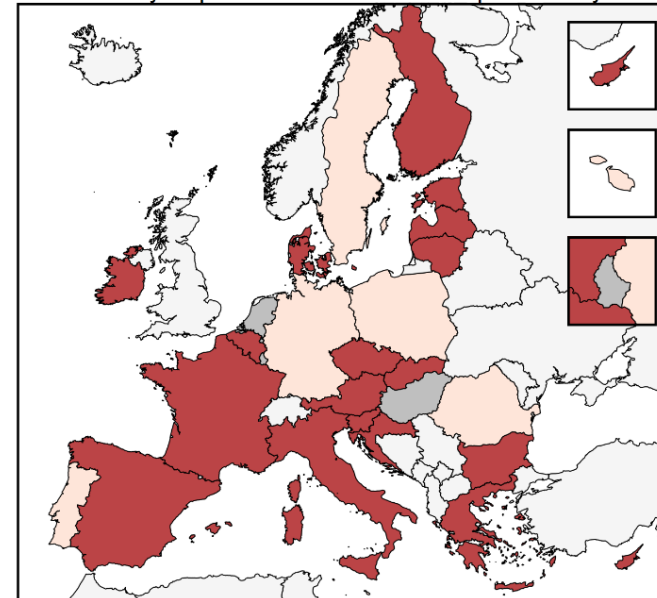

Organisation and Management

- 30 requests pre-selected out of 60 submitted
- Topics include e.g., crisis management and prevention, regional and national governance systems, innovation and partnership building
- Example project: Strengthening development cooperation ecosystem: coherence, partnerships, impact

Policy area: Organisation and management (30 requests selected/60 submitted)

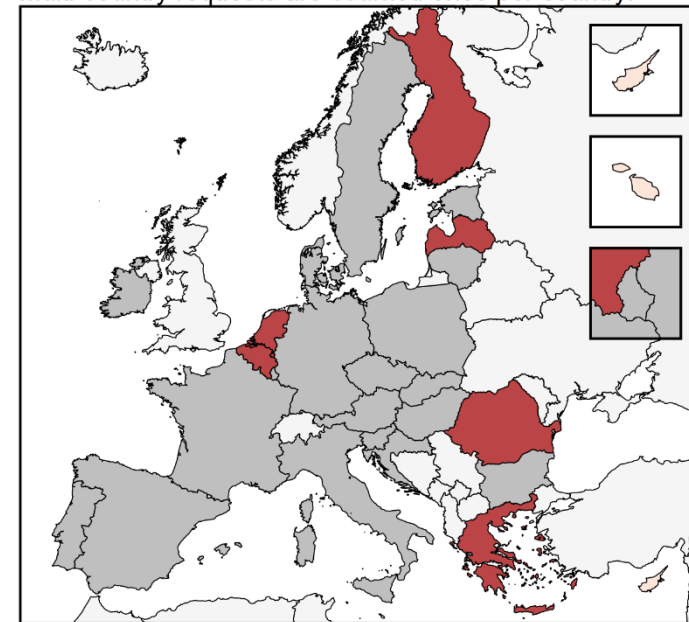

Integrity and accountability

- 6 requests pre-selected out of 13
- Topics include e.g. support for the update of legislative integrity frameworks, development of internal audit systems, strengthening of governance frameworks
- Example project: Strengthening the strategic approach to public integrity, including the integrity of public procurement processes and data-driven approach in procurement risk management

Policy area: Integrity and accountability (6 requests selected/13 submitted)

Multi-country requests are counted once per country.

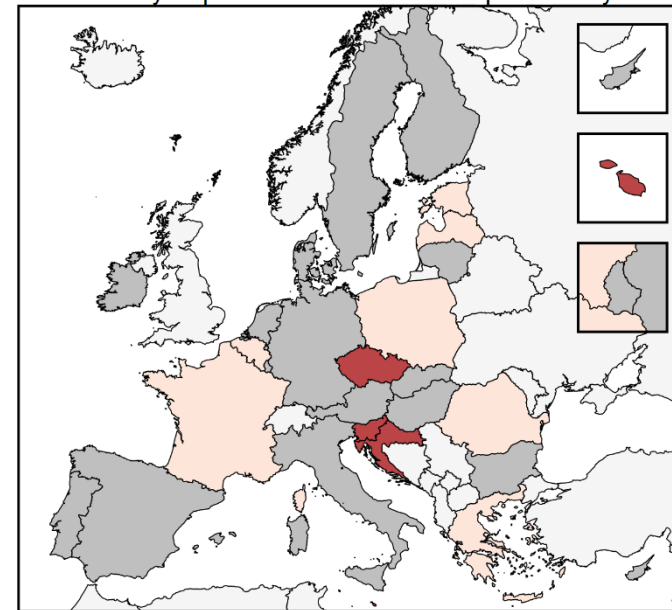

Justice and Rule of Law

- 4 request pre-selected out of 16 submitted
- Topics include e.g. child-friendly legal systems & efficiency of justice
- Example project: Ensuring the best interest of the child in civil court proceedings.

Policy area: Justice and rule of law (4 requests selected/16 submitted)

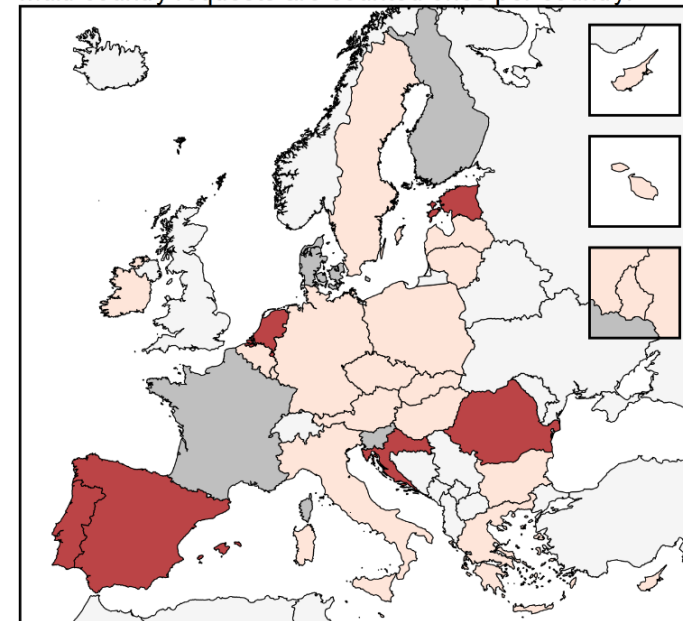

Services and Digitalisation

- 8 request pre-selected out of 50 submitted
- Topics include e.g. digital transformation for regional and local authorities, data governance, AI
- Example project: Establishment of data governance, business intelligence and analytics offices at agencies to support the data economy and seamless data exchange

Policy area: Services and digitalisation (8 requests selected/50 submitted)

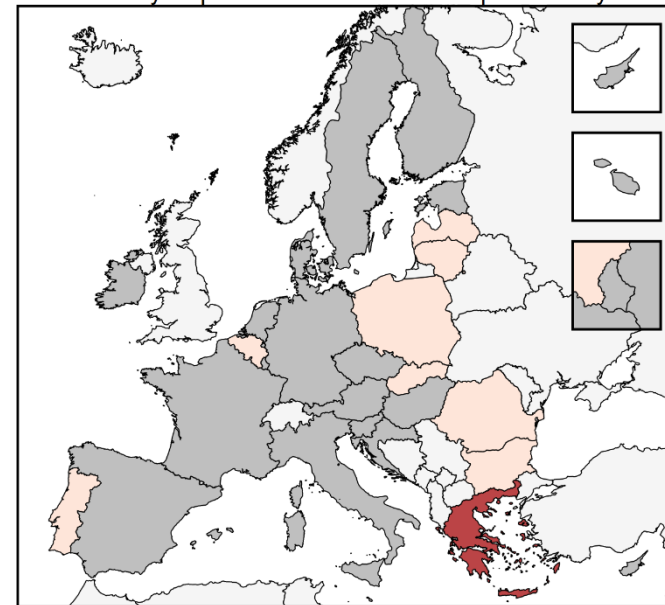

Policy

- 1 request pre-selected out of 15 submitted
- Topics include development of impact assessment, professionalization of policy-making, institutionalizing behavioral science for policy-making
- Example Project: Institutionalizing Behavioral Science for Policy Making to Improve Reform Efforts

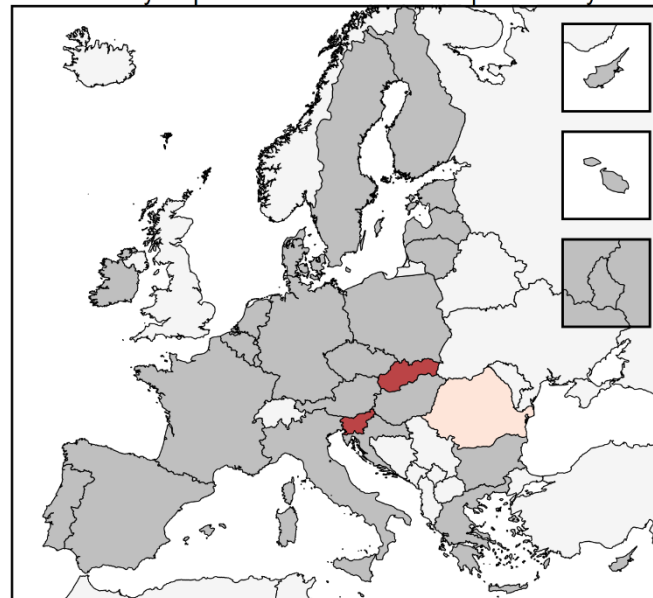

Management of EU funds
